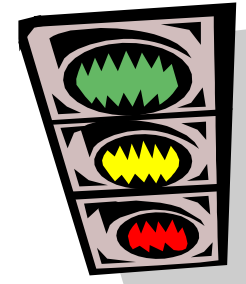

What Can I Dispose of in the Collection Boxes?

Yes

- Prescription Medications, *except for narcotics or controlled substances*
- Over-the-Counter Medications
- Medication Samples
- Pet Medications
- Vitamins
- Liquid Medication in Glass or Leak-Proof Containers
- Medicated Ointments and Lotions
- Inhalers

- Narcotics and Other Controlled Substances
- Bloody or infectious waste
- Personal Care Products
- Hydrogen Peroxide

Why Should I Use the Colorado Medication Take-Back Pilot Project?

- The project offers a way to clear your home of the medications you no longer need – helping to protect the safety of your loved ones, while also protecting the environment.
- Unused medications may fall into the hands of small children and cause accidental poisoning.
- Older children and teens may be tempted to experiment with easily available medications, causing harm to themselves or their friends.
- Flushing or trash disposal of unused and unwanted medications can cause pollution of lakes, streams and water supplies.
- Medications collected in the take-back project are destroyed by incineration for the highest degree of environmental protection.



What if the Project is not Available in My Area?

- Contact your local city or county to see if another medication take-back project is available where you live.

What if I Still Can't Find a Take-Back Project?

- If you do not have access to the Colorado take-back project or another local project, **do not flush** your medications down the toilet or drain.
- Proper trash disposal of medications is your next best option.
- Follow the steps listed below. **The same steps should be followed for the disposal of narcotics and other controlled substances.**
 - Take the medications out of their containers. Mix them with an undesirable substance like kitty litter or used coffee grounds.
 - Conceal or remove personal information, including Rx number, on the empty medicine containers by covering it with black permanent marker or by scratching it off.
 - Wrap the medication mixture and the empty containers in newspaper to help conceal them from children and pets and place them in the trash.
