## Take-Back Program for Unwanted Medicines

Medication take-back programs offer a way to keep unwanted medicines out of the wrong hands while protecting the environment.

### Proper and Improper Disposal of Unwanted Medicines

The detection of trace amounts of medications in wastewater treatment plant effluents and drinking water supplies has raised concerns about potential impacts to ecosystems and human health. Although some of this pollution is caused by metabolized medicines in human and animal waste, a significant portion comes from flushing unwanted drugs and over-the-counter medications. Unwanted medicines kept in the home also may fall into the hands of children or drug abusers.

**People without access to a take-back program or local collection events should avoid flushing medicine down the drain or toilet. Instead, unwanted medicine should be mixed with kitty litter or coffee grounds to make it unusable, and discarded in the household trash.**

### The Pilot Program

Tamper-resistant collection boxes available at several Denver metro-area locations are intended for prescription medications and over-the-counter products, but cannot accept narcotics, controlled substances or medications from clinics, hospitals or nursing homes. A guidebook attached to each box will explain which products can be deposited. To prevent theft, each box requires two keys, and the contents will be immediately destroyed upon collection to render them unusable. The residual waste materials will be incinerated at a facility licensed to handle medical waste. The pilot program will provide state regulators with data needed to determine if a state-wide program is feasible.

**Accepted:** Prescription medications, over-the-counter medications, medication samples, medications for pets, vitamins, medicated ointments/lotions, inhalers, liquid medication in glass or leak-proof containers.

**Not Accepted:** Needles, thermometers, narcotics and other controlled substances, IV bags, bloody or infectious waste, personal care products, business waste, empty containers, hydrogen peroxide, aerosol cans, plastic bags.
