- A. You must then obtain the signature and seal of the District/Juvenile court and mail the completed report to Vital Records.
- B. Colorado law (C.R.S. 25-2-107 and 25-2-113) authorizes the preparation of a new birth certificate for a person born in Colorado following a decree of paternity. To avoid unnecessary delay in filing the new birth certificate, please complete this form carefully.
- C. For children born outside of Colorado the report of paternity determination will be forwarded to the appropriate state vital statistics office.
- D. Make check or money order payable to Vital Records. Please do not send cash. The fee for processing a change is \$20.00. The first certified copy costs \$17.75. Additional certified copies, ordered at the same time, cost \$10.00 each.

- E. The original birth certificate will be pulled from the working files and indices and placed in a sealed file along with the report of paternity determination. This sealed file shall not be subject to inspection except as provided in section 25-2-113.5, upon order of a court of competent jurisdiction, or as provided by regulation.
